## TERMS AND CONDITIONS FOR PARTICIPATION AT THE EXHIBITION

It is hereby agreed that **DISPLAY ART PLC** (referred to as the "Organiser") grants to the contracting Company / Organisation (hereinafter referred to as the "Exhibitor") the use of the exhibition space (hereinafter referred to as the "Booth") agreed between the two Parties and as clearly defined in the Contract of Participation for the Exhibition with the distinctive title "**TRAVEL EXPO CYPRUS 2024**" (hereinafter the "Exhibition"), which will take place at the **Cyprus State Fair Grounds, Nicosia-Cyprus** (hereinafter the "Exhibition Centre").

The Booth is available for use by the Exhibitor solely for the installation, decoration and operation of the exhibition stand and the corresponding exhibits for the promotion of its products and services and exclusively during the period and hours of operation of the exhibition. The Exhibition is guided **by the following terms & conditions:**

1. The exhibition will be operating on Friday 19/04/2024 16:00-22:00, on Saturday 20/04/2024 16:00-22:00 and on Sunday 21/04/2024 15:00-21:00. Exhibitor's stands should be always operational and in accordance with the schedule of the Exhibition as jointly agreed with this form.
2. The Organizers have the right to refuse any participation or exhibit or service without any obligation to justify the decision.
3. "Subletting", "hosting", or any other service to third parties is **PROHIBITED**. In each Booth there will be only the Exhibitor mentioned in the contract.
4. The Registration Form and therefore the reservation of a Booth is valid only if it is accompanied by the deposit as defined in the Participation form/contract.
5. In case the Exhibitor cancels his participation to the Exhibition, they must inform the Organizers in writing. In this case, all advance payments already paid by the Exhibitor are not refunded and are withheld by the Organization as a minimum cancellation compensation. In case of cancellation of the participation less than **45 days** before the opening date of the Exhibition, the Exhibitor is obliged to pay the full amount relating to the Booth space indicated on the Participation Form/ Contract and in this case the Organizer considers the Booth free and utilises it at its discretion.
6. If the Organizer deems it necessary to modify the exhibition space or arrange the stands for any reason, it has the right to make any change after consultation with the Exhibitors.
7. The Organizer has exclusive responsibility for the distribution of exhibition spaces for the better promotion and grouping of exhibits as well as the general presentation of the exhibition. The Organiser has the right to make changes to the space allocated, either in terms of its dimensions or in terms of location. This does not entitle the exhibitor to withdraw or make any claim.
8. The opening hours and days of the exhibition are determined by the Organization, which has the right to make any changes.
9. It is forbidden before the end of the Exhibition to move exhibits from the Booth. The transportation of exhibits during the opening hours of the Exhibition is prohibited unless there is written approval from the Organisers. Transportation of exhibits and brochures to and from the Exhibition Centre, are solely under the responsibility of the Exhibitor. The Organisers bear no responsibility whatsoever for the promotional material of the exhibitors.
10. Exhibitors are obliged at the end of the exhibition to immediately remove their exhibits from the Exhibition Center as well as the materials and decoration items of their Booth. Otherwise, the Organization has the right to move and store the exhibits at the expense of the Exhibitors. Exhibitors who participate with **Space Only** are obliged to deliver the space empty and clean just as they have received it. Removal of exhibitor's wastage must be done by ordering their own skip, the cost of which is borne exclusively by the exhibitor.

11. The Exhibitor who chooses to participate with only space (**Space Only**) and will construct his own exhibition stand is obliged to use the official contractor-constructor of the Exhibition for the preparation of his stand unless the construction will be undertaken by the Exhibitor themselves with their own human resources. Otherwise, he/she must have the prior approval of the Organiser. All constructions must comply with the aesthetic and safety standards of the exhibition organizers. Any plan for the decoration of the Booth must be submitted for approval to the Organizers in order not to change the basic appearance and structure of the space nor to disturb the other Exhibitors. The Organizer reserves the right at its discretion to remove materials that disturb other Exhibitors or visitors. The Organizer, if it deems that the projection, view, or lighting of other exhibitors is hindered in any way, has the right to intervene.
12. The Organization has the obligation to deliver to the exhibitor the Booth area two (2) days before the start of the Exhibition for Booths Without Structure (**Space Only**) and one (1) day earlier for **Booths With Basic Structure**. The delivery of the stand will take place after the Exhibitor has paid the participation fee.
13. All constructional and / or decorative works should be completed by **Friday 19/04/2024 at 12:00**.
14. The Exhibitor who participates with a structure stand, is obliged to deliver the Booth in the condition in which it was received. If the Exhibitor, his subcontractor, or any of his representatives during the works causes damage or loss to the structure materials of the stands, to the Booth area, or to the property of third parties, the Organizer has the right to claim compensation.
15. In the event that the Exhibitor does not present himself for the undertaking of the agreed Booth, the Organiser reserves the right to grant the said space at its discretion to another interested party without notifying the Exhibitor.
16. Commercial transactions are concluded in the Exhibition Area based on the exhibited samples-exhibits. The Exhibitor is only allowed to advertise and display the products and services inside the rented Booth. The Exhibitor is not allowed to display at its Booth or distribute cards, brochures or printed material of other businesses or companies that do not participate in this Exhibition.
17. Advertising Material or any other sorts of promotion outside the Booth are not allowed and must be limited within the Booth limits. It is forbidden to distribute advertising material in the corridors, in the surrounding areas of the Exhibition Booths and at the entrance. The Organization reserves the right to prohibit the display or distribution of offensive and abusive advertising material and to confiscate such material for as long as the Exhibition lasts.
18. Use in any way of the Exhibition Logo is permitted only with the written approval of the Organiser.
19. The Organizer does not undertake any insurance of exhibits. Exhibitors must be covered with their own insurance policies against any risk during the preparation of the exhibition, its operation and during the removal of the exhibits. Any damage, loss or destruction from fires or natural phenomena or other causes and in general any damage to persons, facilities, machinery, and goods cannot be attributed to the Event. The Organization bears no liability for compensation and has only the usual obligations of the lessor.
20. The presentation of exhibits or the use of sound-systems, or other systems that cause noise disturbance in the exhibition area and disturb other exhibitors are prohibited. In case of significant nuisance, the Organizer reserves the right to terminate the participation agreement by expelling the Exhibitor from the Exhibition Venue. In general, the display and operation of machines that produce high noise levels should be kept to a minimum, to avoid disturbing visitors and exhibitors.
21. Any Audiovisual recording (photographs, video recordings, broadcasts, etc.) of the Exhibitions stands, products and exhibits will be permitted only with the written permission of the Organization.
22. The Organizer assumes no responsibility or liability for the screening of films, the reproduction of audio recordings, the capture of visual images or sounds transferred by electronic means by the Exhibitors. Exhibitors must secure at their own expense and obtain all relevant licenses and consent in accordance with copyright law or violation of the rights of individuals who have legal protection against unauthorized public reproduction or broadcasting of their recordings.
23. In the Exhibition Centre and in the exhibition area, during the preparation of the Booths, the operation hours but also during the dismantling, it is not allowed for any reason to enter any hazardous materials, flammable & explosive substances, harmful substances, etc. that may endanger the safety of the Exhibition, the persons participating in it, the employees, the visitors, and the infrastructure of the Exhibition Area. The Organization reserves the right to remove them immediately and without prior notice to the Exhibitor, products that are unsafe and dangerous.
24. Exhibitors and their staff are obliged to comply with the Regulations and the Terms of participation hereof.

25. The Organizer has the right to cancel or postpone the exhibition if it deems that for any reason it cannot be organized and must inform the exhibitors at least 4 weeks before it takes place. In such a case, the company refunds the amount paid to the exhibitors.
26. In the event that the Exhibition does not take place or is interrupted, or its purpose is altered by any force majeure, earthquake, floods, war or fire or by any other reason not due to an action of the Event, it is agreed that the Exhibitors have no claim or demand regarding any compensation or refund of the amount paid.
27. In the event that the situation with the COVID-19 pandemic or any other pandemic worsens, and restrictive measures are issued by the state that do not allow the exhibition to be held, the exhibition will be cancelled and the entire amount paid will be refunded by the organizers.
28. It is clarified that the contact details and generic information of the Exhibitors as they are listed in the catalogue form may be used in the catalogue entry as well as in the Exhibitors list as it will be posted on the Exhibition's website. In case an Exhibitor does not wish his/her data to be used, he/she must necessarily inform the organizers by submitting his/her Declaration of Participation.
29. In the event that the Exhibitor uses a Transport Company for the delivery of his goods in the Exhibition area, the responsibility for receiving and delivering the goods lies entirely with the Exhibitor himself. The Organization is in no way responsible for the receipt of the Exhibitor's goods but can only indicate the area of the Booth for the placement of the goods.
30. The Exhibitor agrees and accepts that competing companies may choose a space near to, next to or opposite his Booth. In no case can this be a reason to cancel his participation.
31. These Terms and Conditions are governed by the laws of the Republic of Cyprus and any conflict arising shall be treated under the exclusive jurisdiction of the Courts of Cyprus.
32. In case of violation of any term hereof, the wrongful Party is entitled to terminate the Agreement in writing with immediate effect, if the responsible Party does not comply within the reasonable period of time to be notified by the wrongful Party in writing.
